Anti-Doping Testing

Anti-doping Tests may be carried out in accordance with the regulations of Speed Skating Canada.

Transportation

Each skater is responsible for their own transportation during these events.

Entries

All skaters must be competitive members of Speed Skating Canada to compete in the 2011 World Cup Selection Trials, provided that the member is properly registered with the Organizing Committee and meets the criteria set by Speed Skating Canada.

If a properly completed Entry Form has not been received prior to the close of check-in time, the skater shall not be allowed to compete (K2-100).

A complete list of eligible skaters will be available from the Speed Skating Canada Office on October 11.

Entry Deadline

Entries must be submitted at the address below before **12:00h (12:00 p.m.) of Thursday October 20, 2011 using the Official Entry Form**. Entries and entry fees are to be in the hands of the Organizers seven (7) days preceding the event, and any entries that are late will be assessed at double the regular rate at the discretion of the Meet Coordinator. Phone and fax entries are permissible, but any fee covering such skaters so registered must be guaranteed by the home Branch of the skater.

Entry Fee

The entry fee for the 2011 World Cup Selection Trials is **\$75. Late entry fee is \$150** per skater. Entry fees are not refundable.
